Is the entry free of spelling errors?	
Are the basics rules of grammar and punctuation followed?	
<b>Story:</b>	
Were you drawn in right away?	
Does the writer introduce the characters, the situation they are in and why they are in it?	
Is there a clear sense of happenings?	
Has the writer raised questions that you want to see resolved?	
<b>Characterisation:</b>	
Did you get a good sense of the main character/s?	
Do the characters have believable goal/s they are working towards?	
Are you given sufficient details and reasons for behaviour?	
<b>Writing Technique:</b>	
Is the writing well-paced?	
Does the narrative seem natural, give necessary information and advance the story?	
Does each scene promote or advance the story?	
Does the dialogue (or narrative voice) sound true to the character, era and style of the book?	
Is sentence construction and word choice suited to the age group?	
<b>Reader Enjoyability:</b>	
Do you care what happens to the characters?	
Does the writing have a distinct style or voice that impacts positively on you?	
Did the entry touch you emotionally - either with the characters and/or the situation they are in?

<b>Readiness for Submission:</b>

<b>The X Factor</b>

<p><i>We've called it The X Factor for want of a better phrase.</i></p> <p><i>Submission to an editor is only one step on the road to publication. An editor may require corrections or rewrites, but there are qualities that will make them consider putting in their time with the writer to bring them to publication. Publishers may reject a manuscript but will also ask the writer to try again.</i></p> <p><b><i>To mark this item, ignore the errors, and look for the potential.</i></b></p> <p><b><i>Looking only for potential, how do you rate this entry - did it wow you?</i></b></p>

We suggest you read your sheets, then put them away for a few days - then come back to them again so that you are in the right mind to get the best from the feedback. Remember, this is only one person's opinion, and you can take what you want to from your feedback and use it to improve, or you can ignore it - the option remains with you.</b></p>
